



## Terms of Sales

In order to benefit from the services offered by our campsite, we ask you to carefully read the general conditions below. These conditions govern sales of stays and are valid at the time the order is placed.

Booking a stay implies full acceptance of our general conditions.

### RESERVATION CONDITIONS

- The reservation becomes effective only with the agreement of the campsite, after receipt of the deposit and after receipt either of the reservation contract duly completed and signed, or after acceptance of the general conditions of sale when booking online.
- Reservations are only binding on the campsite if the campsite has accepted them, which the campsite is free to do or refuse, depending on availability, and in general, any circumstances likely to harm the campsite. execution of the reservation made. The campsite offers family-oriented stays, in the traditional sense, the accommodation is specially designed for this purpose. The campsite reserves the right to refuse any reservation which is contrary to this principle, or which seeks to divert it.
- Reserving a campsite or rental is made on a strictly personal basis. You cannot under any circumstances sublet or transfer your reservation without the prior consent of the campsite. - Minors must be accompanied by their parents or legal guardians. Camping pitch - The basic package includes the pitch for the tent, caravan or camper van for 1 or 2 people, access to sanitary facilities and reception facilities.

### Location

- Rental accommodations are equipped. The basic package is 2 to 6 places depending on the type of rental.
- The campsite reserves the right to refuse access to the campsite to groups or families presenting with a number of participants greater than the capacity of the rented accommodation.

### PRICES

- The prices indicated are valid for the current year. They correspond to one night, for pitches and per week, and are in euros, VAT included.

#### PAYMENT TERMS

- For reservations made more than 30 days before the start of the stay, a deposit of 30% of the amount of the services reserved must be paid upon reservation at the campsite.

- The balance must be paid upon arrival.

#### CANCELLATION AND MODIFICATIONS

##### 1. Changing your reservation

- Changes to your reservation can be made free of charge, subject to availability at the campsite.

- In the absence of a message from you indicating a postponement of your arrival date, the accommodation may be available for sale again 24 hours after the arrival date mentioned on the contract, and you will consequently lose the benefit from your reservation. 2. Unused services Any interrupted or shortened stay (late arrival, early departure) by you will not give rise to any reimbursement.

3. Cancellation due to the campsite In the event of cancellation due to the campsite, except in cases of force majeure, the stay will be fully refunded. However, this cancellation cannot give rise to the payment of damages.

4. Cancellation by the camper All sums paid will be retained by the campsite.

#### YOUR STAY

##### 1. Arrival

- Arrival days vary depending on the period (inquire directly with the campsite).

- Rental accommodation: On the day of your arrival at the campsite, you will be welcomed from 3:00 p.m. When you hand over the keys to your rental, you will be asked for a deposit of €200 for any damage and an 80 euro cleaning deposit.

2. During your stay It is up to the camper to ensure: the campsite declines all responsibility in the event of theft, fire, bad weather, and in the event of an incident falling under the camper's civil liability.

All customers must comply with the provisions of the internal regulations. Each registered camper is responsible for any disturbances and nuisances caused by people who stay with him or visit him.

3. Departure Rental accommodation: On the departure day indicated on your contract, the rental accommodation must be vacated before 10 a.m. The accommodation will be left in perfect clean condition, any broken or damaged items will be your responsibility, as well as the restoration of the premises if this proves necessary. The deposit will be returned to you at the end of your stay after deduction of compensation retained for any damage noted by the exit inventory. The withholding of the deposit does not exclude additional compensation in the event that the costs exceed the amount thereof. If departure is made outside reception opening hours and without control on our part, the 2 deposit checks will be returned to you. If the accommodation has not been properly cleaned before your departure, the check for 80 euros will be debited.

For any delayed departure, you will be charged an additional day at the current nightly rate.

**ANIMALS** Animals are accepted on the campsite (only one animal per rental, or per pitch) for a fee payable when you book, except for 1st and 2nd category dogs. When allowed, they must be kept on a leash at all times. They are prohibited in buildings and in the children's play area. The vaccination record for dogs and cats must be up to date.

#### EXTRACT FROM THE INTERNAL RULES:

It is displayed at the entrance to the campsite. We thank you for reading it. All customers must comply with the campsite's internal regulations. Failure to comply with the regulations may result in expulsion from the campsite without any refund of the stay.

#### 1- Rules of life on the campsite:

The use of sound devices must not be heard beyond the perimeter of each location.

From 10:30 p.m., it is obligatory that everyone respects their neighbors' right to rest

#### 2- Circulation :

Vehicle traffic is limited to 10 km/h and is prohibited in the campsite between 11 p.m. and 7 a.m.

Everyone present on the campsite must behave like a good father.

#### 3- Visitors:

To preserve the calm of the campsite, your friends can only visit you on foot from 9:30 a.m. to 9:30 p.m. Visitors must go to reception to provide identification and pay the current rate. They will thus have access to the outdoor parking located in front of the campsite.
